AGE LIMIT:

Upper age limit is 65 Years as on the date of Advertisement. No further relaxation is admissible.

PERIOD OF ENGAGEMENT:

The Specialist will be engaged for a period of **Two years (Three visits in week)**. Performance of the Specialist will be assessed by the Head of the Hospital during the said period and he will be reporting to the Head of the Hospital.

Suitable candidates from amongst the applicants will be shortlisted for Interview. Personal interview will be conducted at HAL Hospital, Ojhar Township. Final selection will be made based on the performance in the Interview.

In addition to the remuneration per visits (fixed by HAL), the Visiting Consultants performing surgeries would be paid an extra amount of Rs. 1400/- per surgery. The surgery would be conducted during the period of their regular visiting hours only.

In addition to the aforesaid remuneration per visit / surgery fees, the selected candidate will be eligible for Conveyance reimbursement of Rs. 18/- per km. However, minimum conveyance amount will be Rs. 250/- per visit).
