3. The general requirements and other terms and conditions for the engagement are as under:

1.	Name of position and job location	Young Professionals (YPs) Mumbai, Nagpur and Panaji, Goa
2.	Number of positions	20 (Twenty)
3.	Age Limit	Candidates should be below 35 years of age as on the date of advertisement
4.	Tenure	The maximum tenure of engagement of YPs shall be 04 years. The initial engagement for a person as a Young Professional would be for a period of 02 years. Subject to performance appraisal, further one time extension of 2 years may be granted with the approval of Secretary, CA. The appointment of Young Professionals would be on full-time basis and they would not be permitted to take up any other assignment during the period of appointment as Young Professionals in the Ministry of Corporate Affairs. The appointment of Young Professionals is of temporary nature against the specific jobs/assignments. The appointment can be cancelled at any time by the Ministry without assigning any reasons.
5.	Remuneration (per month)	Rs. 50,000 (Consolidated inclusive of all)
6.	Education Qualification	CA/CS/ICWA
7.	Experience	Minimum 1 year of experience post-passing final examination is required
