- 2. All qualifications should be from Universities/Institutions recognized & approved in
- 3. All computations of age/experience requirement/qualification shall be done w.r.t. the last date of receipt of online application as mentioned in the advertisement.
- 4. Candidates claiming to belong to any particular category shall necessarily have a valid SC/ST/OBC-NCL/Disability/EWS certificate, as the case may be, from the Competent Authority. Where there is vacancy identified for such category,
