In terms of Railway Board's letter Dated 27.07.2022 under reference, it has been decided to fill up following Posts in Gati Shakti Unit (GSU) on Nagpur Division, Central Railway by Re-engagement of Staff, who has been retired from Nagpur Division, Central Railway.

Terms & Conditions

1. The Re-engagement will be valid for a period of one year from the date of engagement and will be extended time to time as per administrative requirement.
2. Employees retired from Nagpur Division Central railway are only eligible for apply.
3. The age limit for re-engagement of retired staff is below 65 years. No re-engaged employee should continue in service beyond 65 years of age.
4. The administration is at liberty to terminate the services of the re-engaged employees even before completion of their term in case their work/conduct is found unsatisfactory.
5. Re-engagement shall be subject to prescribed medical fitness for the relevant Category.
6. Suitability/competency/Safety records/Integrity of the staff will be be adjudged before such re-engagement.
7. Selection of the retired Railway employees for re-engagement is the prerogative and within the competence of the screening committee and no claim against the decision of the competent committee can be made for rejection or non consideration for re-engagement.
8. Retired employees being re-engaged should not have been covered under the safety related Retirement scheme/LARSGESS.
9. The employees removed/Dismissed/compulsory retired as a result of disciplinary action or in review are not eligible for such re-engagement.

10. Retired Railway employees applying for re-engagement should be prepared to work at any station/place and on any position in the cadre irrespective of his post at the time of his retirement.
11. The duty of the re-engaged employee would be the same as applicable to the post against which he/she is re-employed.
12. The duty hours of the re-engaged employees would be 8 hrs or as required. The duty can be changed as per requirement of works by the administration with weekly off for one day.
13. Monthly remuneration of a retired employee being re-engaged is to be governed in terms of Board's letter no. E(NG)II/2010/RC-4/Core/1dated 24.10.219 i.e. reducing pension from his/her last pay drawn (i.e. Basic + DA) at the time of retirement. The monthly fixed remuneration plus full pension shall not exceed the last pay drawn at the time of retirement.
14. Retired Railway employees, re-engaged after retirement are eligible for travelling allowance/Daily allowance, leave, duty pass etc. as per Railway Board's instructions as applicable from time to time.
15. Last Date for submission of the application is **15-04-2025**.
16. Copy the following documents should be attached with the application.
 - vii. Service Certificate
 - viii. Pensioner Identity Card
 - ix. Pension Payment order
17. Staff retired from Nagpur Division, Central Railway desire for re-engagement have to drop their applications in the prescribed Format as Annexure "A" in the Box kept in Prsonnel Department, Astha Cell of this office on or before **15-04-2025**.
18. Kindly note application received after **15-04-2025** will not be accepted.
